Please note: This terms and conditions are applicable for both online and face – to – face lessons.

i. Payment of lessons.

*You are required to pay for your lessons within **48 hours** of your lesson unless discussed otherwise.*

You will receive a payment reminder via email or text (you are asked to inform Molly of this when you first book) from the third last day of the month up until the last day that will disclose the amount that you are due to pay.

If you fail to pay the full amount of the last day of the month your next lesson cost will increase by £5.00.

If for three consecutive months you fail to transfer payment on the last day of the month your hourly/half hourly lesson rate will increase by £5.00 only for your next 4 lessons.

ii. Your lesson times and dates.

In the process of booking your lessons on the following website:

www.solosessionsedinburgh.com

You are asked to disclose your preferred day of the week, time slot and duration of your lesson.

*If you for any reason cannot make your lesson you are required to communicate this to Molly through email: solosessionswithmolly@gmail.com or text: **07580 872 150** (text is preferred). You have to communicate this at least 2 days prior to your lesson date.*

If you fail to communicate this in advance/no preferred lesson date/time is discussed and you miss that lesson, you will still have to pay the full rate (see rates at iii.) for that lesson at the end of the month.

iii. Lesson rates.

As stated in the 'book' section of the solo sessions website (see above) lesson rates are as follows:

Half-hour for piano, vocal or guitar (30 minutes) lessons: £20.00.

Hour for piano, vocal or guitar (60 minutes) lessons: £32.00.

Half-hour for singer/songwriter (30 minutes) lessons: £27.00

Hour for singer/songwriter (30 minutes) lessons: £41.00

iv. Students who are late to lessons.

Students who are late to lessons and haven't communicated 2 days prior to their lesson that will be late, have their lesson for the rest of the lesson time that remains. The lesson rate will not decrease but it will stay the same.

v. Students tasks and lesson plans.

There is no condition or consequence for not completing your 'tasks' however, the lesson plan you receive for each lesson is to let you aim for 3 or 4 new goals every lesson. Your tasks are there for you to complete in time for your next lesson. This is to help you improve your vocal or piano skills.

vi. Termination of lessons.

If you sadly wish to terminate your lessons. You have to give 2 weeks' notice to Molly. Your folder and all of the tracks that have been made for you, you can keep so you continue to use your talent for the rest of your life!

To comply with GDPR, all of your details are deleted from Molly's emails and mobile to protect your personal details.

vii. GDPR regulations.

This clause is to inform you that all your personal details that you enclosed to Molly from the start of lessons are kept in a CRM (Customer relationship management) system and are not shared or enclosed to anyone apart from Molly herself.

You will be asked for a photo of yourself (or your child if you are reading this on behalf of them). This is to add to the header of the 'reviews' section of the 'Solo Sessions' website. The name and age of the student is used against their review and is not seen coinciding with their photograph. This is to protect their identity.
